

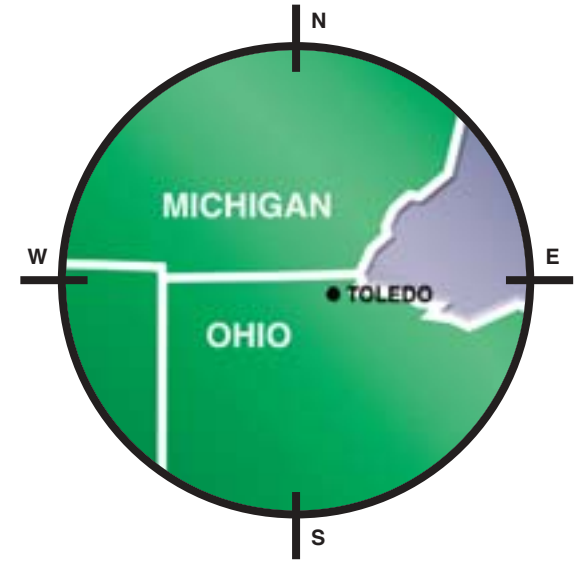

What is NOMMAD?

The Northwest Ohio and Southeast Michigan Mutual Assistance District (NOMMAD) is an industry cooperative effort that parallels area contingency planning and Local Emergency Planning Committee (LEPC) activities. It is an effort by industry to identify and coordinate individual crisis management responsibilities and capabilities.

This, in part, is intended to provide improved coordination and cooperation with government agencies in an emergency. Government participation in activities is strongly encouraged, as is participation in LEPC and area committee planning activities. The following are a few of the successful features:

- ER Response team for member companies
- An industry “Area Contingency Plan”
- Proactive industry participation in area committee and LEPC activities

MISSION STATEMENT:

The Northwest Ohio and Southeast Michigan Mutual Assistance District exists to ensure that participating industrial member companies have resources in an emergency to respond to fires, spills, and other emergency events.

WHAT'S THE COST?

Annual dues:

- Manufacturing facility member: \$250
- Services company member: \$125
- Government entity member: priceless

WHAT IS THE COMMITMENT?

- To provide emergency service if called upon
- Emergency services may be manned equipment, equipment alone, spill clean-up materials, technical resources, or other
- Members who request emergency resources agree to reimburse other members for their costs

HOW IT WORKS

- In an emergency response, when the fire department resources are scarce, or a clean-up contractor is not able to respond for several hours, NOMMAD member resources can respond in one or two hours to save significant future costs.
- Planning, exercise, and training partners
- Cost reimbursed without high markup to the responding organization

- Spill prevention, preparedness and countermeasures (SPCC)
- Network training opportunities
- Drill opportunities and credit

PARTNERING

In the spirit of community cooperation, resources are made available to provide assistance to other companies and the community in the event of a major incident.

EXERCISES

Preventative exercises are conducted year-round, and large-scale exercises are typically conducted once a year. Exercises usually include the U.S. Coast Guard, the local fire department's EMA/ERC's, and one or more industry partners.

OUTREACH

Industry members educate the community on local emergency planning and response activities.
